The Republic of Vanuatu is an archipelago nation spread across 82 islands in the South Pacific Ocean. Each year Vanuatu hosts a wide variety of cultural and art festivals, musical and sporting events, conferences and business related events. Vanuatu offers a very attractive tax regime. As a Vanuatu citizen, you can benefit from zero corporation tax for domestic and international companies and exemption from capital gains.

INVESTMENT REQUIRED

The following investment serves as a qualifier for the Vanuatu citizenship-by-investment programme:

DEVELOPMENT SUPPORT PROGRAMME CONTRIBUTION

- Single applicant: **USD 130,000**
- Applicant and spouse: **USD 150,000**
Family of 3 people: **USD 165,000**
- Family of 4 people: **USD 180,000**
- Each additional dependant: **USD 10,000**

- **Additional government fees apply.**

ELIGIBILITY CRITERIA

To qualify for the Vanuatu citizenship-by-investment programme, an applicant must meet the following criteria:

- Fulfil the investment requirement of the programme.
- Be in good health.
- Have a clean personal and professional background and no criminal records.
- Ensure payment of the due diligence fees.
- Dependent children must be below the age of 25 and dependent parents above the age of 50.

STEPS AND PROCEDURES

Step 1: Sign a retainer agreement for Next Generation Equity to act as your legal advisor for the citizenship application and legal process.

Collect and prepare the documents required.

Pay the due diligence fee.

Submit the application for pre-approval.

Step 2: Receive pre-approval written confirmation to proceed with your application.

Pay the investment amount in full.

Submit the application.

Step 3: The Vanuatu Citizen Commission will examine your citizenship application to check that you have obtained the FIU requisite clearance, documentation and completed the payments.

Step 4: Receive citizenship approval from the Prime Minister.

Step 5: Visit Vanuatu to take your citizenship oath or request for the oath to be taken in the location of your choice (for an extra fee).

Receive the Citizenship Certificate and the passport.
